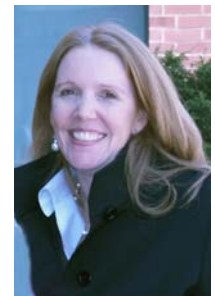
Downtown Allentown: Where We Were, Where We Are, and Where We Want to Go

March 27 – An enthusiastic Joyce Marin, Director of Community and Economic Development of the City of Allentown, took us on a whirlwind tour of the past, present and future of Allentown’s economic development.

After citing the glories of the past of the third largest city in Pennsylvania (Hess’s strawberry fields and all), with a click of her heels we were in the present where “ugly building syndrome” and 70 years of transportation and bank lending policies nationwide had led to the emptying of downtowns.

Not to worry, unlike the Tin Man of the Wizard of Oz, our city has many hearts in the myriad of partners who are working shoulder to shoulder to restore our fair city. Business, art, civic, neighborhood, college, school systems, and economic development groups are focused on making Allentown once again a major destination.

Key to the redevelopment has been the KOZ zones which have aided major employers like PPL and Butz and smaller projects

March 6 – The Rev. Dr. Marc (Marcos) Solt proved he is a Juan of all trades during his March 6 classification presentation, as Marc recounted his life adventures with much wit and humor.

According to Pete Smith, Marc is an “unusual bird” but that’s a good thing! Diverse, spiritual, caring and humorous are other words that describe Marc well.

Marc’s first language is Spanish and he spent most of his youth in Central and South America. His father built cultural radio stations from the ground up. Because of the electrocution thing (he was shocked at times) Marc realized this was not his calling. Marc’s father’s work took him, and his family, which consisted of Marc’s mother and five siblings, to every South American country.

During childhood Marc worked on his father’s car,

played the trumpet (The best thing about that was he quit.), was a beekeeper and handler, taught disadvantaged children in secondary school, cycled, and played soccer.

In fact, he traveled extensively around Mexico playing soccer, and playing professionally for the Philadelphia Adams and Dallas Tornados. In 1980, when he had hair and a beard, he participated in the Olympic Trials. He still plays twice a week.

Marc’s other passions include his wife and family (numero uno passion), theology, and financial planning with Prudential Securities. He has been married to Ruth his partner, soul-mate, best friend, and mother of their five children, for 27 years. Classification Talk



Janet Roth

April 3 – Faced with the intimidation that all of us seem to go through when our classification talk looms, Janet Roth met the challenge expertly. From start to finish, with a warm and personal slide presentation, she did just what classification means: a wonderful history of Janet.

She traced her pilgrimage from her birth in Pittsburgh to her current responsibility as executive director of the Trexler Trust. When she was two years old, the family moved to Johnstown where her father found a job as a coal miner. In 1978, the mine roof fell in. Undeterred, her father enrolled in college at 50 years of age and completed a degree in accounting.

Janet enrolled at Shippensburg University where she majored in journalism/communications. During summer she worked in a fruit

market and also got a job as a country music disc jockey (a “position” in radio that also included reading the local obituaries).

She moved to Allentown in 1986 to work at the Pennsylvania Stage Company, then on to Tylersmith Graphics and soon thereafter to Trexler Trust as an assistant to the director. While at Trexler, and after sitting through Trustee meetings, she decided she needed a clearer understanding of how to read a balance sheet. (And she wanted to understand what Dexter Baker was talking about!) So by 2000 she had completed her MBA in finance from DeSales University.

Janet then moved to Maryland to work for another foundation, but shortly thereafter she took a grant-writing and public relations job with the Baltimore Area Council, B.S.A. But a position again became available at Trexler and it did not take much persuasion to have her return to Allentown.

She has some historic Rotarian roots. Janet’s grandfather was a founding member of the Windber Rotary Club and her grandmother was a Rotary Ann. (For you newcomers, this was the women’s “auxiliary” of Rotary, prior to Rotary International – finally – opening the door for

full female membership.) And, of course, Tom Christman set a fine example of not just her “leader” but also an Allentown Rotary leader.
